- 5.2.1 Report from Principal
 - We have 186 students at the present time. We are down from our numbers last year at this time, families have moved out of the territory for various reasons
 - Classes are healthy. Kindergarten has 21 students. Grade 1 classes are small.
 - Extra Resource help in French and English has been added.
 - September 28, 2017, Verdun students will be getting their bus. It has been trying but hopefully the new bus will help sort out the bus challenges.
 - New Project Allocation from School Board coming soon: \$20 000.
 - Literacy Week was a Great Success. Book Fair was well received.
 - Terry Fox Run will take place on September 29, 2017.
 - On September 28, 2017, Eddie Nolan a local supporter of Terry Fox and cancer survivor will speak to students about his experiences with Terry Fox.
 - On October 6, 2017 the whole school will be attending an Apple Picking trip.
 - Awaiting for the hiring of a new Librarian. Ms. Benoit is helping in the library for now.
 - Honey will be harvested and be available for purchase on October 19, 2017. There will be 176 (140 grams) jars available from 22.7 kg of honey collected.
 - All classes will be involved in Community Service Projects this year.
 - Fusion Jeunesse Non-Profit Organization will be involved with both Robotics and Drama for grades 4, 5 and 6.

YMCA

St. Columba House

The Youth After School Program has commenced, there are approximately 20 students from St. Gabriel enrolled.
